## MARYLAND ENSEMBLE THEATRE'S FUN COMPANY 2014-2015 SEASON!

**FREDERICK, MD** (September 3, 2014) - **Maryland Ensemble Theatre's (MET)** family theatre **The Fun Company** is proud to announce an exciting new season featuring an expanded schedule of five plays in a brand new performance venue. In September of last year Maryland Ensemble Theatre began a \$100,000 Capital Campaign to convert 1,700 square feet of offices adjacent to MET current spaces into a new performance venue. While being a flexible playing space, it will primarily service MET's educational programming and as the home of The Fun Company's full season. "We are thrilled to launch this season in the new venue. We are hoping that by having its own performance space the Fun Company can create an even more inviting and interactive experience for our young theatergoers," said **Julie Herber, The Artistic Director of The Fun Company**. "We have some great classic titles and a dash of new and exciting stories to share with our family audiences. We are pleased to announce that we now have the luxury of adding more performances to fit into those ever-busy schedules." Herber is also planning new programming for the Fun Company this year. "With the success of our 'Live Story Time at Dancing Bear', we hope to add programming for toddlers as well. We've had several requests to offer shows for 2-5 year olds and we plan on doing just that, now that we have the space and time to do that."

The season will open September 27 with a stage adaptation of the popular children's book "**Stellaluna**" by **Jannell Cannon** adapted for the stage by playwright **Saskia Janse** and composer **Guus Ponsioen**. Julie Herber will direct the show, which will run through October 26. "This is a delightful and inventive adaptation of the delightful tale of the sweet megabat that incorporates song, dance, puppetry and ASL. It is guaranteed to be a visual treat!"

On November 29, "**Junie B. Jones in Jingle Bells Batman Smells**" returns after its sold out extended run last year. "I can't tell you how many requests we've had to bring back Junie B. Jones and her group of lovable friends," said Herber who will once again direct. "The show filled houses last season and we look forward to sharing the holidays once again with the kids in Room One." "Junie B. Jones" adapted by **Allison Gregory** from the book by **Barbara Park** tell the story of our heroine, Junie B. Jones, who must play Secret Santa to her least favorite classmate, Tattletale May. Will Junie B. give May exactly what she thinks she deserves or will the holiday spirit force a change of heart? Will the Holiday Sing-Along go as planned? It's all part of the festive adventure in Room One that is "Jingle Bells, Batman Smells".

Beginning February 7 is the stage version of the classic tale by **Antoine de Saint-Exupéry**, "**The Little Prince**". The most-read and most-translated book in the French language was adapted for the stage by **Rick Cummins** and **John Scoullar** and will be directed by MET Ensemble Member, **Matt Lee**. "Matt Lee's lively and experimental style is sure to add a whole lot of awesome to the show," said Herber. With regard to the show Herber said, "It's a true ensemble piece that is full of enchantment and heart. This is going to be a special treat for families to share together and it's our hope that it will spark many thoughtful discussions."

Another classic tale, **Hans Christian Anderson's "The Little Mermaid"**, will be the fourth show in The Fun Company's season and will begin April 4, 2015. The show will be a World Premiere adaptation by MET Ensemble Member, **Devin Gaither**. "After the success of her last work, 'My Monster and Me', once again Devin Gaither puts pen to paper to adapt this beloved story," said Herber. "Devin's scripts are always full of much more than just fluff and I'm sure she's got a lot up her sleeve to bring this undersea world to life that will give **Disney** a run for their money." MET Ensemble member and **Comedy Pigs** member, **Laura Stark**, will direct the show.
